



SECRET LAB GAME START 2017 Grand Prix (SUNTEC CONVENTION CENTRE HALL 401, 402 & 403 on 14th to 15th October) - LETTER OF WAIVER AND INDEMNITY (THIS "LETTER")

I, the undersigned (the "**Participant**"), wish to participate in the **Secretlab Game Start Grand Prix 2017** (the "**Event**").

In consideration of Secretlab allowing me to participate in the Event:-

1. I represent and warrant that I am in good health and have no physical condition that would endanger my life while participating in the Event. I further represent and warrant that I am of at least 140 cm in height.
2. While reasonable precaution will be taken by Secretlab and its agent(s) to ensure participants' safety, I understand that as the Participant, I take part at my own risk. Without prejudice to all other rights or remedies available to Secretlab, I hereby agree to comply with the rules of the Event as set by Secretlab and that Secretlab and its agent(s) will not be held liable and no claims will be made and no actions will be taken against Secretlab, for any injury or death arising from participating in the Event or for any loss of or damage to my property occurring in the course of the Event, except for such injury or death that is caused directly by Secretlab's or its agent(s)' breach of legal duty of care.

Without prejudice to all other rights or remedies available to Secretlab, I hereby irrevocably undertake with Secretlab that if, in the course of the Event, I deliberately or negligently cause any injury (whether fatal or otherwise) to any person or any damage to or loss of any property of any person (an "**Indemnity Event**"), I shall indemnify Secretlab in respect of any losses or expenses incurred or suffered by Secretlab arising from such an Indemnity Event, including but not limited to losses or expenses incurred in respect of any claims or actions made or taken against Secretlab.
4. This Letter shall be governed by and construed in accordance with the laws of Singapore. If any provision of this letter or part thereof is rendered void, illegal or unenforceable by any legislation to which it is subject, it shall be rendered void, illegal or unenforceable to that extent and no further.
5. I represent and warrant that I am at least 18 years of age; or that, I am under 18 years of age, and my parent/ legal guardian has signed the below acknowledgement.
